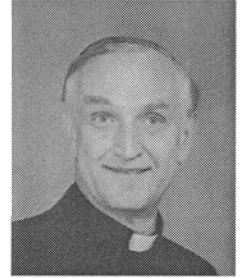

Dougherty.</p>	<p>- On 4-15-04, the Archdiocese approved the Review Board's recommendation that allegation of sexual abuse of minors was credible. - On 6-14-04, Rev. Dougherty was informed that the Archdiocese found the allegations credible, imposed restrictions on his priestly ministry and referred the case to the Vatican for review of laicization. - On 9-10-04, the Archdiocese imposed further restrictions on his priestly ministry and informed him that his name would not appear in the 2005 Catholic Directory. - On 10-21-04, Rev. Dougherty wrote to the Vatican to request voluntary laicization.</p>
