Grumm Thomas J. Ordained: 5-17-75						- On 9-10-04, the Archdiocese imposed further restrictions on Rev. Grumm's priestly ministry and informed him that his name would not appear in the 2005 Catholic Directory On 10-12-04, Rev. Grumm agreed to the removal of his priestly faculties, to forgo the Church penal process and to accept the imposition of a supervised life of prayer and penance.

Grumm and placed him on Administrative Leave Rev. Grumm was admitted to St. John Vianney Hospital from April to November 2002 for treatment.	- On 10-3-03, Cardinal Bevilacqua notified Bishop Harry Flynn of St. Paul, Minnesota that Rev. Grumm was residing in his diocese with restricted faculties On 6-14-04, Rev. Grumm was notified that the Archdiocese found the allegations credible, imposed restrictions on his priestly ministry and referred the case to the Vatican for review of laicization.
