

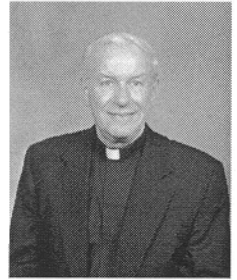

He continued to receive psychological treatment.</p>	<p>- On 11-15-04, Rev. Henry was informed that the Archdiocese found the allegations credible, imposed restrictions on his priestly ministry and referred the case to the Vatican for review of laicization.                      - On 12-22-04, Rev. Henry agreed to the removal of his priestly faculties, to forgo the Church penal process and to accept the imposition of a supervised life of prayer and penance.</p>
