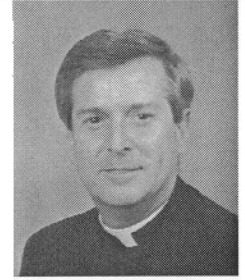

Kohler that his current assignment was terminated and he was not to have any contact with the complainant. - In May 1994, he underwent a psychological evaluation at the St. John Vianney Hospital and sent to St. John Vianney Hospital for treatment. - Rev. Kohler was placed on Administrative Leave on 6-1-94.	
	June 1993	7-11-1994	Fifteen –year-old boy photographed by Kohler and other priest. Criminal charge brought ⁵	Resident Priest, St. Charles Borromeo, Bensalem (2/86-6/94)	- He was not given a priestly assignment and his faculties were restricted to private Mass.	- On 9-10-04, the Archdiocese imposed further restrictions on Rev. Kohler's priestly ministry and informed him that his name would not appear in the 2005 Catholic Directory.

⁵ Rev. Kohler was charged with one count of obscenity in connection with William O'Connell, a former Rhode Island cleric. O'Connell was charged with sexually assaulting a boy and taking obscene pictures. A search warrant was issued and non-illegal pornographic tapes were confiscated from Rev. Kohler's home in the Villas, New Jersey.
