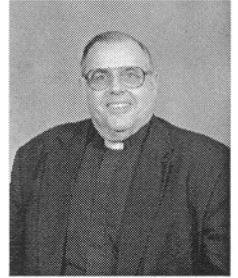

Kornacki was placed on Administrative Leave on 8-1-03. - In July 2003, Rev. Kornacki was admitted to St. John Vianney Hospital for treatment.</p>	<p>- On 5-27-04, Rev. Kornacki was indicted in federal court for possession of child pornography. - On 6-2-04, Rev. Kornacki was informed that the Archdiocese found the allegations credible, imposed restrictions on his priestly ministry and referred the case to the Vatican for review of laicization.</p>

<p>Kornacki Matthew J. Ordained: 5-19-73</p>						<p>- On 8-24-04, Rev. Kornacki pleaded guilty before U.S. District Judge R. Barclay Surrick on one count of violation of the federal statute for possession of child pornography.</p> <p>- On 9-10-04, the Archdiocese imposed further restrictions on Rev. Kornacki's priestly ministry and informed him that his name would not appear in the 2005 Catholic Directory.</p> <p>- On 10-13-04, Rev. Kornacki agreed to the removal of his priestly faculties, to forgo the Church penal process and to accept the imposition of a supervised life of prayer and penance.</p> <p>- On 11-18-04, Rev. Kornacki was sentenced to 30 months in federal prison plus a \$6,000.00 fine.</p>
