McLoughlin's priestly ministry and informed him that his name would not appear in the 2005 Catholic Directory On 10-15-04, Rev. McLoughlin agreed to the removal of his priestly faculties, to forgo the Church penal process and to accept the imposition of a supervised life of prayer and penance On 11-12-04, Rev. McLoughlin was informed that the Archdiocese found the allegations credible, imposed restrictions on his priestly ministry and referred the case to the Vatican for review of laicization.
