"The abuse started in Our Lady of Peace Catholic School, he told Our Sunday Visitor, when his family returned to Erie after living for a short time in California. Michael Barletta (PA 40th GJ, p. 396). Five credibly accused abuser priests had access to K.J. and countless minor children; which begs the question what, not whether, their many confreres knew about their abuse of children. Abuse on this scale is not possible without bystanders and enablers, and points to the Church's failure to teach and practice its own social doctrine of corporate sin and responsibility. Priests who had a hand in these matters continue to minister in good standing with no accountability.	■ Fr. John Fischer in ≈ 1970 reported Bartletta's molestation of a child to Bishop Alfred Watson and Msgr. William R. Hastings, both of whom ignored the accusation; none of the three went to the police, and Fischer's confreres "laughed it off" (PA 40th GJ, p. 393) ■ Erie Vicar General Fr. James Burke received credible allegations from a Barletta victim in 1988, and wrote in 1991 that it was not worth acting upon (PA 40th GJ, p. 395). ■ Bishop Donald Trautman allowed Barletta to minister in good standing from 1995-2002, despite his admitting to molesting 25 children, removing him only because of the Dallas Charter (PA 40th GJ, p. 396).

\*K.J. is a public survivor of clergy sexual abuse who detailed multiple allegations against priests in interviews with Our Sunday Visitor and others. He has a compelling voice and put his name to the material in the first column of this table; he does not need me to speak for him, nor do I intend to. K.J. has not named his abusers, though they are publicly discoverable. The individuals listed in this table inhabited time and place with K.J., which makes his case an important key to understanding the dynamics of abuse in the Diocese of Erie. K.J. is a school classmate of mine, though we only know each other as a result of the 40th Pennsylvania Grand Jury. -J.F.
